Lunch will be on your own at Tusker’s. You are not allowed to bring food into the zoo. If you opt to bring your own, there are picnic tables in the parking lot.

After lunch, you can either spend more time in the zoo (there are 2,000 animals in the zoo) or proceed to the Botanical gardens to photograph there.

We will be traveling 1-95. There will be two pick up places for this trip. Please designate which you prefer (1) Hardeeville Super Walmart on Hwy 278. Park in the Walmart lot behind the service station (2) MacDonald’s at Exit 33 off 1-95. Park in the MacDonald’s parking lot.

The deadline date is March 13, 2018. The trip is based on having a minimum of 30 people signed up by the deadline date
